## APPLICATION GUIDELINES TO THE TRUSTEES' DISCRETIONARY FUND EMERGENCY GRANT SCHEME. Please read before completing this form

The Addington Fund assists working farmers who are experiencing hardship in times of emergency, for example following an illness, bereavement, accident, extreme weather conditions or certain animal diseases.

We realise in such times you will be worried about looking after the animals on your farm, but your circumstances may be causing a temporary cash flow problem which is making things difficult to feed your sheep or cattle.

### Are you eligible?

#### To apply:

- You are a working farmer and your main income must be from farming an agricultural holding and you are experiencing hardship because of an emergency situation through no fault of your own.
- You are unable to provide funding for this yourset by looking at normal business practices, such as selling store animals or drawing on any reserves/savings/overdraft facility.

Please note that grants are made at the discretion of Trustees and priority will be given to applicants depending on their circumstances. Regrettably, we cannot help everyone who comes to us so please try and describe your particular situation as clearly as possible.

### How we help:

We help with a one-off delivery of animal feed for the livestock on your farm, to provide you with some short-term relief and this is supplied from our charity feed partner. In order to arrange this, we will need to share your contact details (but not your circumstances) with our partner feed suppliers. In other situations our trustees can consider one-off support to help alleviate hardship relating to an emergency situation which is outside your control.
