

THE GEORGE STEPHENS TRUST FUND APPLICATION FOR FINANCIAL ASSISTANCE

THE GEORGE STEPHENS TRUST FUND (GSTF) provides certain goods to eligible farm workers, i.e. if you are or were employed on a farm, for 5 consecutive years within the last 10 years and are resident in England or Wales or you are a widow, widower, or a dependent of someone who was employed on a farm, for 5 consecutive years within the last 10 years and are resident in England or Wales.

The following information is required in order to assess each application.

Employment history in agriculture:

- The name and address of the current employer(s), or if currently not working, your previous employer(s)
- The capacity in which the eligible applicant worked
- The approximate dates of each employment

The total weekly income from all sources: in order to qualify the weekly income must not exceed the current minimum wage for full-time employment.

Types of items grants have been awarded for: (although other items will be considered)

- Washing machine/White goods
- Telephone
- Lighting
- Furnishings for home e.g. curtains
- Shower
- Bed
- Contribution towards replacement windows
- Help towards household heating costs
- Help with deposit on rented house (some Councils provide this too)
- Disability equipment
- Any other items at discretion of Addington Fund trustees.

If successful, any grant awarded will be paid to the supplier of the item or goods you have requested. Grants are not awarded in the form of cash directly to an applicant.

Applications must be on an Addington Fund application form and supplementary information provided. If successful, Addington will source and pay for the identified item which will be delivered to you.
